

SUMMARY ANNUAL REPORT

For BENETEMPS, INC. 401(K) PLAN

This is a summary of the annual report for BENETEMPS, INC. 401(K) PLAN, EIN 02-0452407, Plan No. 001, for period January 01, 2018 through December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Plan expenses were \$123,512. These expenses included \$3,498 in administrative expenses, and \$119,458 in benefits paid to participants and beneficiaries. A total of 42 persons were participants in or beneficiaries of the plan at the end of the plan year, although some of these persons may not yet have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,197,984 as of December 31, 2018, compared to \$1,314,775 as of January 01, 2018. During the plan year the plan experienced a decrease in its net assets of \$116,791. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plans assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$6,721, including employer contributions of \$7,274, employee contributions of \$64,042, and earnings from investments of (\$64,595).
